1.0 YACHT AGENCY

Yacht Solutions operates a professional yacht agency in Thailand, offering assistance in a variety of areas. We can organise the tasks that seem daunting or need specialist skills. We have a good working relationship with the local governing departments such as Customs, Immigration, and Harbour Master, ensuring all legal procedures are adhered to. We also have good contacts and the required permits to organise cruises to most Asian countries. Anything you need, we will source, organise and deliver in a professional and timely manner.

1.1 VESSEL CLEARANCE

Checking into Thailand is a time-consuming and complicated process. It is based around Thai values and many of the officials do not speak English. Yacht Solutions can save you time and hassle by acting as your agent for clearances in and out.

For vessels wishing to stay in Thailand longer than 30 days we recommend all crew acquire a 60 day Tourist Visa from the nearest Thai Consulate prior to arrival (this visa can be then extended for an additional 30 days in the country). This visa is not essential, but it will save your vessel the cost of renewing visas every 30 days. The captain will be cleared in as crew, they will be issued a 30 day yacht visa on arrival and will then require to organise a crew bond which is outlined below to leave the country after 30 days. On return the tourist visa will be enacted.

For this service to run smoothly we will need the following:

- original vessel registration documents;
- clearance papers from last port;
- all crew and passenger passports;
- letter of authority from owner to captain to act as captain for your boat;
- **If the vessel ownership is under a company name**, please contact us to receive templates of the correct paperwork required.

1.1.1 The Procedure

Once you have arrived in Phuket waters we will meet your vessel at any location and collect all necessary documentation. We will then proceed to check you and your vessel into Thailand. This procedure normally takes 3 to 5 hours to receive the correct documentation and stamps.

Your vessel will then be entitled to stay in Thai waters for 6 months or for 1 year if your vessel is berthed in a marina. Once this period is close to expiring we can then have the customs declaration extended a further 3 times to a maximum of 2 years. This is outlined in the vessel extension section below.

The fee for this is 8,000 THB per clearance including 3 crew, with a further 500 THB per extra crew or passenger. Credit cards are accepted. All charges are subject to 7% VAT.

For weekends and public holidays an additional 1,500 THB charge is required for the government officials.

1.2 CUSTOMS EXTENSION

Yacht Solutions can organise an extension of stay in Thai waters for your vessel with Customs. To ensure the smooth extension of your customs temporary importation from 6 to 12 months, 12 months to 18 months or 18 months to 24 months the following will be needed:

- Customs clearance form no. 7001 and schedule 1.
- Registration certificate
- Photocopy of owner passport – signed in blue pen
- Photocopy of captain passport – signed in blue pen – *If captain cleared in vessel originally*

This service is advised to be done no later than one week before the expiry date on the Customs form.

The fee for 6 month to 12 months is 10,000 THB, payable before the event. Credit cards are accepted. All charges are subject to 7% VAT.

The fee for 12 month to 18 months is 12,000 THB, payable before the event. Credit cards are accepted. All charges are subject to 7% VAT.

The fee for 18 month to 24 months is 14,000 THB, payable before the event. Credit cards are accepted. All charges are subject to 7% VAT.

1.3 CREW BONDS

Thailand has a policy that any crew member on a vessel entering Thailand be granted a maximum stay of 30 days. At any time the crew wish to leave the country within this time frame, or once the visa expires, the crew member must either leave by sea again, or if they wish to leave by any other method, deposit a 20,000 THB bond. Immigration will then issue the correct paperwork. Once this has been issued, one can only leave through the specified exit point and on the date applied for. Once one has left the country the funds made available to collect in Phuket three weeks after the exit date.

Yacht Solutions offers to ease this by organising it for you. We will do all the above and post the money, saving you a lot of time. For this we require the following:

- Copy of air or bus ticket; and
- passport.

This service is advised to be done no later than three days before the expiry date in the passport and cannot be done on weekends or public holidays.

The fee for this is 6,500 THB. Credit cards are accepted. All charges are subject to 7% VAT.

Once the crew have been in the country with the vessel for their visa length, they will need to leave to organise a new visa. Upon return a crew bond will need to be placed as well.

Yacht Solutions can organise this and require the following;

- Full inbound flight details;
- Photocopy of passport

The above will be collected prior to the crew leaving the country and all will be prepared for their arrival.

The fee for this is 8,000 THB. Credit cards are accepted. All charges are subject to 7% VAT.

1.4 VISA APPLICATIONS AND EXTENSION

For persons cleared into Thailand as a passenger, there are two methods to extend your visa. If you enter with a 30 day tourist visa on arrival you can receive a 7 day extension. This is the maximum you can receive.

Yacht Solutions can organise this and pay the extension fee on your behalf.

The fee for this is 4,500 THB. Credit cards are accepted. All charges are subject to 7% VAT.

The second method is to arrive with a 60 day tourist visa from a Thai embassy/ consul. Once this is close to expiry you can receive a 30 day extension. This is the maximum you can receive.

Yacht Solutions can organise this and pay the extension fee on your behalf.

The fee for this is 5,000 THB. Credit cards are accepted. All charges are subject to 7% VAT.

1.5 CRUISING PERMITS, GUIDES, INFORMATION AND ADVICE

1.5.1 Myanmar

CRUISING PERMITS, GUIDES, INFORMATION AND ADVICE

Myanmar

Yacht Solutions holds permits to legally allow vessels to travel to Myanmar. We will act as your agents in all respects to clear your vessel out of Thailand, into Myanmar, liaise with the governing bodies to gain permissions, meet with the officials in Kawthoung, clear the vessel back out of Myanmar and finally back into Thailand.

We can also offer experienced Western guides for sightseeing and diving, crew, including captains, deck hands and chefs. The standard procedure is simple and starts a minimum of 10 days prior to your departure. At this point, we will need:

- 80% payment of the total fees;
- photocopy of ship's registration documents;
- crew and passenger lists;
- itinerary - we can help you plan this;
- Photocopies of all passports;
- Picture of vessel showing vessel name; and
- Four passport size photographs per passenger and crew.

We will need to identify where exactly you wish to go, as there are extra permissions and fees for certain areas. We will then apply to Yangon for your permit. Once we have received your permissions we can start to process your vessel. The next steps are as follows:

- final 20% payment of the total fees, plus expenses;

- clear vessel out of Thailand (optional);
- clear vessel into Myanmar;
- liaise with officials in Kawthoung;
- organise local guide;
- clear vessel out of Myanmar; and
- clear vessel into Thailand (optional).

Prior to the vessel leaving Thai waters we will need the following (if you have chosen for us to clear you out of Thailand we will already have these):

- original ship's registration document;
- all passports;
- crew and passenger lists; and
- clearance out papers for Thailand.

Our staff will then drive to Kawthoung and clear your vessel into Myanmar and meet with you. You will need to take on a government guide (compulsory) who will liaise with any naval patrol boats or other officials during your trip. Once this is finalised you will be free to travel on your submitted itinerary only. Finally, if you have contracted us for Thai clearance, we will meet you back in Phuket to hand over all your documentation.

The fees for all the above services are as follows:

- Yacht Solutions fee – Yangon : US\$2,000
- Yacht Solutions fee – Mergui Archipelago : US\$1,000
- Permit to operate in Myanmar : US\$2,000
- Visa charge, per person : US\$20
- Passenger fee, per person, Myeik Archipelago, 5 days/ 4 nights : US\$150, US\$20 per extra day
- Government guide : US\$30 per day
- Kawthoung agent fee : US\$150
- Myanmar clearance out : US\$130
- Charts : US\$45 per chart
- Port fees : 4,500 THB
- Guide tip : 1,500 THB per week

NB: There will be additional fees to pay to the various governing bodies for trips to Yangon and further, these will be advised once an itinerary has been submitted.

Credit cards are accepted. All charges are subject to 7% VAT.

Andaman Islands

Yacht Solutions can organise for vessels to travel to the Andaman Islands for pleasure. We will act as your agents in all respects to clear your vessel out of Thailand, appoint local agents in Port Blair to correctly liaise with the governing bodies to gain permissions, meet with the officials, clear the vessel in and back out of the Andaman's and finally back into Thailand.

Our agents in Port Blair are well established and can assist with anything required once there. As the organisers of the Andaman Sea Rally (www.andamnserrally.com), we have a lot of experience in the Andaman's, and can ensure your trip runs smoothly. We can organise special permissions to dive with your own diving gear, to sail in and fly out (and visa versa) and to visit remote areas.

- The first step is to gain visas for India from the nearest consul. Please contact them for more information. **No-one can enter the Andaman Islands without a valid Indian visa.**

The standard procedure is simple and starts a minimum of 10 days prior to your departure. At this point, we will need the following:

- full payment of the total fees;
- photocopy of ship's registration documents;
- crew and passenger lists; and
- an itinerary

Once in the Andaman's you will need to identify where exactly you wish to go, as there are extra permissions and fees for certain areas. The agent will then apply to Port Blair for your permissions.

The next steps are as follows:

- clear vessel out of Thailand (optional, see additional file);
- clear vessel into Port Blair, through our local agents;
- liaise with officials in Port Blair, through our local agents;
- organise local guide (optional);
- clear vessel out of the Andaman's; and
- clear vessel into Thailand (optional, see additional file).

Prior to the vessel leaving Thai waters we will need the following (if you have chosen for us to clear you out of Thailand we will already have these):

- original ship's registration document;
- all passports;
- crew and passenger lists; and
- clearance out papers for Thailand.

Our staff will then fax all details of your trip to our local agents who will then meet your vessel on arrival. We will offer detailed procedures for the arrival in the Andaman's. If you wish to engage in scuba diving, you will need to take on a government-approved guide, who will liaise with any naval patrol boats or other officials during your trip. Once this is finalised you will be free to travel on your submitted itinerary only. Once you have completed your trip, our agents will meet with you again in Port Blair to clear you out. Finally, if you have contracted us for Thai clearance, we will meet you back in Phuket to hand over all your documentation.

The fees for all the above services are as follows:

- Andaman agent fee : US\$250 (payable to the agent)
- Diving guide : US\$70 per day (payable to the agent)
- Charts : US\$55 per chart

Credit cards are accepted with a 3% surcharge. All charges are subject to 7% VAT.

1.6 PROVISIONING SERVICE

Yacht Solutions offers a provisioning service to save you time and the hassle. For the inexperienced, shopping in Thailand can be rather difficult. We offer to take that away from you by offering the following services;

1. English-speaking native shopping guide. This person will be an experienced Thai cook with a working knowledge of Phuket markets and food outlets. They can accompany yourself or your chef around Phuket offering advice, help expedite purchases, assist with the language and clarify local variations.
2. Provisioning list and delivery service. This service offers both local and international lists outlining all foods available. One simply outlines what you require and we will deliver them to your vessel. To ensure timely arrivals of goods please adhere to the below:
 - a) Local food produce can be ordered 24 hrs prior to the required time and delivered to your vessel.
 - b) Some international produce may not be available in Phuket, however we can source from suppliers and have lists for you to choose from. Orders MUST be placed 5 days prior to delivery.

Please ask us for more information on these services and to receive the provisioning order lists.

The fees as follows:

- 800 THB per hour for an English-speaking native shopping guide.
- Cost plus 10% surcharge on all food orders plus delivery fee (depending on location).
- Local sourcing and purchasing of goods Cost plus 10% + staff time costs

Credit cards are accepted. All charges are subject to 7% VAT.

For crew seeking positions please go to our web site and download the crew application form or apply directly to us. Applications for the position(s) you would like to pursue must be completed in full and returned via email. In addition, the following items should be submitted by post, fax (+6676239139) or email (crew@yachtsolutions.net):

- a résumé / C.V. printed on *white* paper. Include boat names, sizes, dates onboard and position(s) held;
- a passport size photograph with a light background (.jpeg or .tiff);
- copies of all marine and navigational licenses and certificates held;
- letters of recommendation from previous employers;
- a list of references with current contact numbers; and
- chefs and cooks are required to provide a printed, professional one-week **sample menu**, including breakfast, lunch, dinner, desserts and hors d'oeuvres, and highlight any speciality training (breads, pastries, etc.). Photographs of your work are strongly suggested as they are excellent selling tools for your skills.

Upon completion of your file you will be notified, and your file will be sent to all our network agents worldwide. If any suitable work arises we will contact you. Please ensure you keep us updated with your availability, contact details and experience.

1.8 FUEL AND WATER BUNKERAGE

Yacht Solutions can organise to have your vessel refuelled and watered within the Phuket area. For smaller vessels the most simple and cost-effective way is to proceed to one of the marinas and use the facilities there. It is advisable to book. There is also the option of visiting one of the fuel and water barges in Ao Chalong or in Patong. The fuel barge is not always contactable and often helps to contact them prior to arrival. There are three barges operating in Chalong year round and Patong in the high season. One of the barges offers a roaming service and can visit most other places with a surcharge of approximately 8000 THB for the delivery.

To save you time and hassle we can organise this service for you and offer payment facilities. Simply contact agency@yachtsolutions.net for more information.

For larger vessels it is essential to use the fuel barges and to order the fuel. The barges will meet with you at most pre-requested places. Please contact us for more information.

For vessels over 500 gross tonnes, duty free fuel can be sought within 24hrs of leaving after clearance. You will need to contact us to organise it and then proceed to Ao Makam deepwater port to facilitate this.

1.9 THAI COOKING ADVICE AND TRAINING

The Boathouse culinary workshops are open to everyone. The cost of the two day course, per person, is 2800 THB - inclusive of service charge and taxes. The price is subject to change without notice. It is possible to attend one session only at 1800 THB net with lunch. Participants' spouses or friends are also encouraged to join in the lunch. A small supplement of 500 THB net is charged per person. Tailor-made courses for groups can be arranged.

1.9.2 Pat's Home Thai Cooking

Pat, originally from Bangkok, lived in California for eight years and having returned to Phuket she wishes to share with you her cuisine expertise and secrets in the comfort and exotic surroundings of her gracious home.

Day time courses are held at the home of Pat Tienthong near Phuket Town. Evening courses are run in a mountainous, jungle setting overlooking Phuket Town and Chalong Bay, and are private classes only. Advanced reservations are required for the four dish course that includes a certificate, recipes and lunch. Training, involving more advanced courses, can be arranged as well for chefs and kitchen/galley staff.

Both courses offer individual cooking of four dishes. The day time course is from 09:00 to 13:00 including lunch, and costs 1500 THB per person, and the evening course is from 17:30 onwards and costs 2500 THB. Credit cards are accepted. All charges are subject to 7% VAT.
